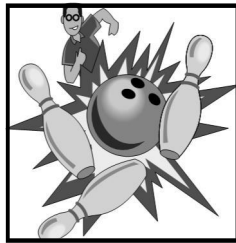
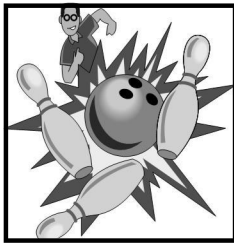

NOTES FROM THE TREASURER

Our finances for the period ending November 30, 2017 continued to be favorable. Our cash balances increased by \$218 over October while our Uncollected Accounts Receivables decreased by \$389. Regrettably, the annual rate increase on four insurance policies totaled \$818.

Our November total income was marginally less than budget, but our year to date income was \$2,637 more than budgeted. Our November daily operating expenses was over budget by \$5,161, due mainly to a large purchase of fertilizer and rye grass which had been budgeted earlier, and utilities continue to over budget, due mostly to electrical costs. However, our year to date daily operating expenses through November was under budget by \$10,070. More good news is that our revenues have allowed us to fund the two reserve funds which were delayed from January, due to Hurricane Matthew last fall.

We had three CD's which matured in mid to late November and two more which matured on December 1st. These were combined into two separate CD's and reinvested at an improved rate of 1.25%, all with a 13 month maturity date. This reduced the number of CD's we need to track while at the same time gaining a favorable rate of return on investments.

Hope you all had a Merry Christmas and best wishes for a healthy and Happy New Year.

GARDEN CLUB

Keeping a garden journal is an excellent way to aid you in maintaining the optimum health for your garden. Record first and last frost dates, periods of drought and rain, dates and duration of insect and weed populations, plus any changes to your regular gardening routines.

Utilizing the USDA hardiness zone map and the American Horticultural heat zone map are also invaluable aids to gardening. The heat zone for our area is Zone 8. This means that we experience 91-120 days of temperature highs of 86 degrees or above. The USDA hardiness zone map, updated in 2012 due to climate warming, classifies Coastal South Carolina as Zone 8b. This reflects an average minimum low temperature of 15 to 20 degrees for our area.

With the above tools and knowledge the gardener is better equipped to choose durable plants that can tolerate wet periods, drought, heat and cold. The majority of landscape plants have been classified by hardiness, with an increasing number being classified by heat zones as well. By consulting the tags on plants for these numbers and other optimal planting information, you can be assured of the best possible plant for this zone. If plants do not have a tag, consult the nursery expert.

Thanks to John Drohan for another enjoyable and successful holiday decoration event. The December 9th event was attended by 16 residents. Our thanks go out to all who assisted with this event as well.

We will begin our spring season in March. Watch the News and Views for more information. You can also call Gary or Ginny Cooper at 843-347-2969 if you have any questions.

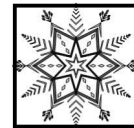

Medical Awareness Communication

VIAL of LIFE Program

What is the Vial of Life Program?

It is a medical information profile of an individual that provides critical data in the event a medical condition occurs that requires emergency medical resources to respond.

Is this program free of charge and does it provide directions on how to complete and assemble the package?

Yes, the program is free and describes how to complete the package.

How do I obtain this package?

You can obtain this package via the Internet at VialofLife.com or contact Mary Johnson at 843-347-6897.

How does this information help responding Horry County Fire Rescue personnel treat patients?

The information provides a host of answers to standard questions asked such as current medical issues, medications and dosage currently taken, recent hospitalizations, emergency contacts etc.

Do I have to fill in all the requested information and how often do I need to update the form?

No, all information provided is voluntary and should be updated if significant medical issues occur or your medications change.

Do we have to fill out two separate forms for a husband and wife?

Yes, each member of the household should complete separate forms along with their respective list of medications being taken.

Where should I place our information?

Vial of Life packets (place in a clear sandwich bag with one of the red decal/white cross facing outward) and affix with a magnet to the outside of your refrigerator where it is visible to responding medical personnel. Place the other decal on a glass surface outside the front door.

POSITION AVAILABLE

The Myrtle Trace Homeowners Association will receive the applications of interested persons to provide, as a private contractor, Accounts Receivable services. The Accounts Receivable Contractor retained shall receive, for his or her services, compensation of \$3,300.00 per year. Said amount shall be paid in equal monthly installments of \$275.00 on the first day of the month.

Duties of the Accounts Receivable Contractor include, but are not limited to the following:

- a. Check the Association mailbox (101 Myrtle Trace Drive) and the lock box at the Association Clubhouse daily for incoming correspondence. Also collect and deposit money from the use of the copy machine.
- b. Distribute all mail and communications received daily to the appropriate addressee or to the persons designated by the Board of Directors.
- c. Review for accuracy of all checks and monies received then post the monies received in a receivable ledger. Deposit all monies received in the designated bank account. Retain the bank receipts to the end of the year and delivered to the Administrative Consultant.
- d. Contact Association members regarding non-payment or over-payment of monthly maintenance fees. Apply, record and collect penalty fees where applicable. Notify Board of Directors when a member is in arrears over ninety (90) days.
- e. Furnish closing attorneys with information regarding the status of a home seller's account and amounts due from the purchaser. Utilize computer templates to transmit electronically those documents requested.
- f. Accept payments from residents for mailboxes, posts and nameplates and submit signed work order to the Maintenance Contractor regarding when and where to install such items.
- g. Order supplies of letters and numbers for nameplates from our designated supplier for delivery to our Maintenance Contractor as needed.
- h. Notify the Board of Directors, the Administrative Consultant and the Communications Chairperson of house closings as they occur. Notify Communication Chairperson and Architectural Review Chairperson of changes in mailing addresses of non-resident members as they occur.
- i. All records are to be computerized. Copies of real estate correspondence, HUD-1, ALTA Real Estate Settlement Statements, supporting documents and general correspondence will be maintained as hard copies and filed in the Clubhouse after one year.
- j. Provide Administrative Consultant with monthly reports.
- k. A Real Estate Tracking Sheet will be maintained for all real estate closings that includes all pertinent data needed to generate Certificate of Assessment notices to law firms.
- l. Accounts Receivable will provide orientation, training and updating relating to the responsibilities under this contract to an individual(s) designated by the Board of Directors.
- m. Any other reasonable duties to be agreed upon by the Board of Directors for the Association and the Accounts Receivable Contractor.

The Accounts Receivable Contractor is required to represent and acknowledge that he/she is an independent contractor and not an employee of the Association.

The Accounts Receivable Contractor shall provide, at their own expense and on their own premises, the necessary equipment, software and supplies for the performance of the agreed upon services.

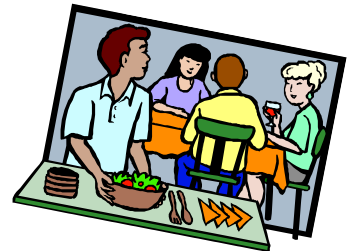

MYRTLE TRACE HOMEOWNERS ASSOCIATION EMERGENCY CONTACTS POLICY

For those residents who wish to avail themselves of the service, the Myrtle Trace Homeowners Association will maintain a list of emergency contacts, persons to be notified in the event that illness, death or other debilitating circumstance should render the resident incapable of making decisions for himself or herself. Each Myrtle Trace resident shall be offered an opportunity to designate the names, addresses and telephone numbers of two persons to be notified in the instance of emergency. The Association will contact the listed persons and inform them that an emergency situation exists on advice from a friend, relative, acquaintance, caregiver, doctor, church, community organization, governmental agency, funeral director or other person or entity charged with or interested in the welfare of a resident.

Provision of the aforesaid service shall not charge the Association, its agents or representatives, with any active obligation regarding a listing. It shall not be the duty of the Association, its agents or representatives to seek out instances in which the persons designated on a resident's listing should be contacted. The Association shall have no obligation to make inquiries concerning the propriety of a request that listed persons be contacted. Updating the information contained on the list shall be entirely the responsibility of the resident for whom it is maintained and the Association does not warrant the correctness of the information contained in any listing.

Residents recognize that there are inherent risks in any release of information. The Association, its agents and representatives, by its maintenance of the emergency information database and its contact of persons listed therein assumes no responsibility for any loss that may befall the resident or the persons designated by that resident.

The emergency contacts database will be maintained and contacts to those listed thereon will be made by a Keeper of Emergency Information who shall be appointed annually by the Board and who will be one of the two Directors at Large then serving on the Board. The first such appointment will be made, and this policy will become effective, on the date of the first regular monthly meeting of the 2016 Board of Directors.

Those residents, cognizant of all the above, who wish to avail themselves of this service shall complete and return, to the person designated by the Board of Directors as its Keeper of Emergency Information, a completed Information Sheet in essentially the following form:

EMERGENCY CONTACT INFORMATION

The Myrtle Trace Homeowners Association offers to maintain contact information for the residents of Myrtle Trace in the event of a medical or other emergency. This information will become a part of the MTHOA database and will be maintained by its Board designated Keeper of Emergency Information.
