Signs - New signs for back gate should be in sometime this week.

John Beam has submitted couple preliminary drawings for signs similar to front entrance signs to be considered and submitted to board for approval. Committee voted to submit suggestion to board. Landscaping has been approved by board for beautification of back gate which will be planted by Garden club.

Trees/Garden Club - Ms. Southard has identified 7 trees which are diseased Another tree has been identified that has been hit by lightning several times. Recommend to board trees be removed.
